INFORMATION ON THE PROCESSING OF PERSONAL DATA [art. 13 e 14 Reg. (EU) 2016/679]

Regulation (EU) n. 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data

In order to respect the principle of transparency in compliance with the Regulation (EU) n. 2016/679 (hereinafter "Regulation"), as a data subject we wish to inform you that the processing of your personal data is carried out in compliance with the conditions set below.

1. DATA CONTROLLER AND CONTACT DATA

Pursuant to art. 4 of the Regulation, the Data Controller is **GALLO & PARTNERS S.R.L.** based in Via Rezzonico, 6 - 35131 — PADOVA (contact details: tel. 049 651029, e-mail studio@gallopartners.com).

The Data Supervisor and the Data Protection Officer are not envisaged and appointed by the Data Controller

2. PROVISION OF DATA

This website processes data based on consent. By using or consulting this website, visitors and Users explicitly approve this privacy statement and consent to the processing of their personal data in relation to the methods and purposes described below, including any disclosure to third parties if necessary for the provision of a service.

The provision of data and therefore the Consent to the collection and processing of data are optional; the User can deny consent, and can revoke a consent already provided at any time (via the Contact link on the website). However, denying consent may make it impossible to provide some services and the browsing experience on the site may be compromised.

3. TYPES OF DATA COLLECTED

Like all websites, this site also makes us of log files to store the information automatically collected during the Users' visits. The information collected could be the following:

- 3.1 Internet Protocol Address (IP);
- 3.2 Type of browser and device parameters used to connect to the site;
- 3.3 Name of the internet service provider (ISP);

- 3.4 Date and time of visit;
- 3.5 Origin and exit web pages of the visitor;
- 3.6 The number of clicks, if needed.

The aforementioned information are processed in an automated form, and collected in an exclusively aggregated form in order to verify the correct functioning of the site; for security reasons, such information will be treated on the basis of the legitimate interests of the owner.

For security purposes (spam filters, firewalls, virus detection), the automatically recorded data may possibly also include personal data such as the IP address, which in accordance with applicable laws could be used in order to block attempts to damage the site itself or to cause damage to other Users. These data are never used for the identification or profiling of the User, but only for the purpose of protecting the site and its Users, and will be treated on the basis of the legitimate interests of the owner.

If the site allows the insertion of comments, or in the case of specific services requested by the User, the website automatically detects and records some identification data of the User, including the email address. These data are voluntarily provided by the User at the time of the request for service provision. By entering a comment or other information, the User expressly accepts the privacy policy, and in particular agrees that the contents entered are freely disclosed to third parties.

4. PURPOSE OF DATA PROCESSING

The data received will be used exclusively for the provision of the requested service and only for the time necessary for the provision of the service.

The information that the website Users will deem to make public through the services and tools made available to them, are provided by the User knowingly and voluntarily, exempting this site from any liability regarding potential violations of the law. The User shall verify whether they have permission to enter personal data of third parties or content protected by national and international standards.

The data collected from the site during its operation are used exclusively for the purposes indicated above and stored for the time strictly necessary to carry out the specified activities.

The data used for security purposes (blocking attempts to damage the site) are retained for 7 days.

5. RECIPIENTS OF PERSONAL DATA

The personal data collected may be communicated, within the limits strictly relevant to the obligations, tasks and purposes indicated above, to the following subjects or categories of subjects:

- 5.1 practitioners (both natural and legal persons) to whom the Data Controller should entrust tasks for the performance of certain activities (e.g. accountants, consultants, translators, correspondents, patent office examiners) or the resolution of disputes (e.g. lawyers);
- 5.2 subjects in relation to which the current legislation provides for the obligation to communicate in compliance with the requirements of the tax and accounting legislation;
- 5.3 credit institutions, insurance companies;
- 5.4 supervisory bodies, judicial authorities;

5.5 public administrations.

The owner undertakes to entrust the data exclusively to subjects who, due to their technological connotation, experience, ability and reliability, provide a suitable guarantee of full compliance with the Regulations, with particular regard to data security and respect for the fundamental freedoms of the data subject.

The list of Data Processors of the data you provide will be made available to you upon request to the Data Controller.

Your personal data will not be disseminated.

Furthermore, your data may be made accessible to people (employees and collaborators) specifically authorized and trained by the Data Controller.

6. RIGHTS OF THE INTERESTED PARTY

The User has the right to request from the Data Controller the following:

- access to their data (Article 15 of the Regulation);
- the correction of data (Article 16);
- the cancellation of data (Article 17);
- the restriction of processing (Article 18).

He also has the right:

- to oppose the processing of data (Article 21);
- to oppose the data portability (Article 20);
- to request confirmation about the existence of his personal data (right of access);
- to know their source;
- to obtain intelligible communication;
- to receive information about the logic, methods and purposes of the processing;
- to anonymously obtain the updating, integration, and blocking of the data processed in violation of the law, including those no longer necessary for the pursuit of the purposes for which they were collected:
- in cases of consent-based processing, to receive the data he provided to the owner, in a structured and readable form by a data processor and in a format commonly used by an electronic device, and only at the cost of the support used, if needed;
- as well as, more generally, to exercise all the rights that are recognized by the legal provisions in force.

Finally, we remind you that you have the right to complain to the supervisory authority (Privacy Guarantor www.garanteprivacy.it) if you believe that there has been a violation of your data, and you have the right to revoke the consent given at any time, without thereby affecting the lawfulness of the processing carried out before the revocation. You can exercise your rights at any time by contacting the Data Controller or by writing an email to the addresses indicated in point 1.

7. METHODS OF DATA PROCESSING

The processing of your personal data will be carried out according to the principles of lawfulness, fairness and transparency, to protect your privacy and your rights. The Data Controller also undertakes to process your data in compliance with the principle of "minimization", that is, acquiring and processing the data limited to what is necessary with respect to the stated purposes. These data will be stored on information technologies, and on any other type of suitable support,

in compliance with the Regulation, so as to guarantee a level of security adequate to the risk treatment (Article 32 of the Regulation).

8. PLACE OF DATA PROCESSING

The data collected by the site are processed at the headquarters of the Data Controller, and at the Web Hosting datacenter. The Web Hosting Seeweb srl, which processes the data on behalf of the Owner, is co-owner of the data processing, is located in the European Economic Area and acts in accordance with European standards.

9. COOKIE

As is customary on most websites, this site also uses cookies, small text files that allow to store information on visitors' preferences, to improve the functionality of the site, to simplify navigation by automating procedures (eg. Login, site language) and to analyse the use of the website.

Session cookies are essential in order to differentiate the connected Users, and are useful to prevent a requested feature from being provided to the wrong User, as well as for security purposes to prevent cyber attacks on the site. Session cookies do not contain personal data and last only for the current session, i.e. until the browser is closed. Consent is not required.

10. DEACTIVATION OF COOKIES

Cookies are linked to the browser used and **can be disabled directly from the browser**, thus refusing / revoking consent to the use of cookies. It should be noted that disabling cookies may prevent the correct use of some functions of the website itself.

11. THIRD-PARTY COOKIES
